Jeremy Shackelford is the new Regional Manager of WSFS' Greater Wilmington Region. He joined WSFS with significant retail banking experience attained through various roles, including as a Senior Vice President and Regional Manager for Susquehanna Bank and BB&T (the latter acquired the former) where he supported the growth and expansion of the retail branch network and small business lending. Mr. Shackelford will oversee nine WSFS banking offices, all in New Castle County, Del. He began his banking career in 2002 with Bank of America and prior to that served 10 years in the United States Air Force. Mr. Shackelford has earned multiple accreditations, certificates and industry licenses throughout his professional and military careers, and has served with more than eight community and business organizations in the Delaware Valley. Mr. Shackelford will report to Rick Wright.

Shelly R. Kavanagh has been promoted to Regional Manager of the Southern Region, which encompasses 15 Banking Offices in Kent and Sussex Counties, Del. Most recently, Ms. Kavanagh was a Retail Program Manager at WSFS where she successfully augmented the Bank's retail sales process.
